### **NOTICE OF RACE**

**The Dry Pants Model Yacht Club cordially invites all club members of good standing with a CR-914 to attend the Plattwood Series at Plattwood Park Pond in Deep River, CT.**

#### **ELIGIBILITY**

DPMYC members of good standing with a CR-914 class yachts.

All Yachts must abide by class rules as modified by the Sailing Instructions. Verifications may be conducted as directed by the RD or if a protest is lodged by another competitor.

#### **RULES**

The Regatta will be governed by the 2021-2024 RACING RULES OF SAILING (RRS) as changed by RRS Appendix E, this Notice of Race (NOR), the Sailing Instructions (SI's) and the CR-914 Class Rules.

#### **SCHEDULE**

SPRING SERIES Starts April 21<sup>st</sup> and continues until 8 weeks of competition are complete.

NO RACING MAY 5<sup>th</sup>

FALL SERIES Starts September 8<sup>th</sup> and continues until 8 weeks of competition are complete.

NO RACING OCTOBER 27<sup>TH</sup>

SUNDAY's 10:30 - 12:00 (First warning signal at 10:30 and No warning signal after 12:00)

POSTPONEMENT If a Sunday's racing is postponed because of inclement weather, insufficient number of boats (5 boats minimum) or number of races completed (minimum of 5 races completed), additional Sundays will be added until 8 weeks of competition are complete.

#### **MEASUREMENT**

Boats may be checked for class compliance prior to the first race

Class rule 12.4 is changed to read any cell configuration or cell chemistry is acceptable.

#### **SAILING INSTRUCTIONS**

Sailing Instruction will be emailed to club members at least 1 week prior to April 21<sup>st</sup>.

## **SCORING**

The weekly race day will be scored using the Low Point System as described in rule A4. The series scoring will also be a Low Point System with the 5 lowest weekly scores counting for the championship.

## **AWARDS**

Trophies will be presented to the top three skippers in the Series

## **CORINTHIAN SPIRIT**

Remember that we are always to be in friendly competition. In the event of any behavior which is deemed to be a breach of good manners or sportsmanship, or which may bring the sport into disrepute, the Race Director or other designated Race Official will protest the party(ies) in accordance with RRS 2.

Penalties available to the RD and/or Race Committee include a one-turn penalty without a hearing, exclusion from the race in question, or expulsion from the regatta.

Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept liability for the material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
