NOTICE OF RACE

1. RULES

This event will be governed by the Racing Rules of Sailing 2025-2028 (RRS) as changed by RRS Appendix E, this Notice of Race (NOR), the Sailing Instructions (SI's) and the DF 95 Class Rules.

2. ELIGIBILITY & MEASUREMENT

All class legal DF 95's are welcomed to participate in this Regatta. All boats are expected to be class legal and the race committee reserves the right to confirm DF 95 class rule conformity on a random basis.

3. FEES

The entry fee is \$30, LUNCH & LIMITED DRINKS PROVIDED TO SAILORS, feel free to bring your own lunch.

5. SAILING INSTRUCTIONS

Final Sailing Instructions revisions will be available on the DPMYC web site (dpmyc.org), AMYA website and emailed to all registered participants supplying an email address approximately one week prior to the Regatta. Race Committee reserves the right to sort the racing fleet into heats based on fleet size and conditions.

SPECIAL NOTES:

DPMYC may utilize GPS controlled/positioned and remotely placed course buoys.

DPMYC may deploy RC rescue and buoy launch as needed.

6. VENUE

7. SCORING

The low point scoring system will apply (RRS-A4)

8. PRIZES

Trophies will be presented to the top five skippers.

9. CORINTHIAN SPIRIT

Remember that we are always to be in friendly competition. In the event of any behavior which is deemed to be a breach of good manners or sportsmanship, or which may bring the sport into disrepute, the Race Director or other designated Race Official will protest the party(ies) in accordance with RRS 2 and may ask any sailor to leave.

Penalties available to the RD and/or Race Committee include a one-turn penalty without a hearing exclusion from the race in question, or expulsion from the regatta.

Competitors participate in the regatta entirely at their own risk. See RRS 3, Decision to Race. The organizing authority will not accept liability for the material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.
